## What is domain name monitoring?

- Auditing your domain name portfolio and third party registrations prior to the implementation of a study.
- **Detecting** the registration of new domain names that may conflict with your rights.
- Acting quickly to defend your interests before the various technical intermediaries and arbitration centres.
